we report as follows:

The inspection was performed on 14.08.2013 in the above location.

Goods presented for inspection were found distributed as follows:

- Flat warehouse No 2

: 80mt in big bags

- Flat warehouse No 3 : 10mt in bags of 50kg

Sampling and analyses:

Increments were drawn from randomly selected bags at the accessible places from the entire shipment, following GAFTA 124 Sampling rules. Subsequently composite samples for the total quantity stored, i.e. 90mt Bulgarian wheat-limets (triticum monococcum) in bulk were formed, tagged, sealed and submitted for analyses in SGS Laboratory in Varna. The following results obtained:
